

CHECKLIST FOR COLLECTING AND REMITTING SALES TAX

Whether or not Pennsylvania's 6% sales tax is collected on an item is determined by checking the Retailers' Information booklet, REV-717, available from the Department of Revenue website at www.revenue.state.pa.us. The publication lists items by category.

Some common items sold by Friends Groups:

Taxable	Nontaxable
Soft drinks and sports drinks (pp. 18/19)	Ice (pp. 18/19)
Food and ice cream (pp. 18/19)	Firewood (p. 35)
Books (p. 22) includes calendars	Water (pp. 18/19)
Souvenirs (p. 32)	T-Shirts, hats (pp. 14, 15)
	Laundry machine proceeds (p. 7)

Friends Groups must collect sales tax and report all sales to PPFF by the 10th of the month immediately following the month of sale. The monthly Department of Revenue Sales Tax Return is completed at PPFF by the 15th of the month.

Sales are reported using the standard PPFF deposit form on which a breakdown of non-taxable sales, taxable sales, and tax collected is recorded by your group in the box in the lower right-hand corner.

To help track sales, PPFF has standard multiple-part sales receipts that can be supplied to the Friends Group upon request.

If taxable sales are made "tax included," an easy formula for determining the portion that is sales tax is:

Total Collected on Taxable Sales / 106% = \$\$ Amount of taxable sales

Total Collected on Taxable Sales - \$\$ Amount of taxable sales = Sales Tax

FOR EXAMPLE: To find sales tax on \$25.00 of taxable sales

\$25.00/106% = \$23.58 Taxable Sales = \$23.58

\$25.00 - \$23.58 = \$1.42 Sales Tax Collected = \$1.42
